

Program Purpose . . .



In order to support the efforts of non-profit organizations to provide low-income families with the opportunity to own their own home, MPW offers a grant program to offset

a portion of the cost of connecting to the water and wastewater systems.

In order to qualify for MPW's grant program, low-income families must first meet qualifications and application criteria of the organization and/or program through which the housing opportunity is provided.

The qualifying organization must be a non-profit organization with at least 80% of its funding being used to provide housing and assistance to low income families.

Grant recipients and participants in this program must adhere to and follow all rules, regulations, policies and procedures set forth by MPW.

MPW will review this program annually and may make changes to the program (including changes in funding levels) after these annual reviews. MPW is not obligated to fund this program in the event of operating budget constraints.
